



## Extract from the Minutes of the meeting of the general meeting of the Baku Religious Community of European Jews.

European Jews. 09/11/2023

Present: 101 members of the community.

Chairman of the meeting: Sharovsky A.Ya..

Secretary of the meeting: Pitelman A.G.

Agenda of the meeting: - entry into the World Zionist Organization.

E. Brenneisen spoke on the first issue.

We decided to support the demands and conditions of the World Zionist Organization listed in Article 7 of the WZO Constitution, including the recognition of all Zionist organizations, to adopt the Constitution of the Federation and the Jerusalem Program, as well as the following requirements and conditions:

1. Cooperation with the World Zionist Organization (WZO), as well as with Zionist organizations in other countries;
2. Exchange of experience with Zionist organizations abroad;
3. Cooperation with Jewish youth organizations, attracting young people to the ideas of Zionism;
4. Admission to membership of the Organization of any Zionist organization associated with the WZO, associations or individuals, if this does not contradict the current legislation of the Republic of Azerbaijan and if they recognize the Charter of the Federation and the WZO program ("Jerusalem Program");
5. Contribution to the aliyah of the Jewish people of the republic.
6. Denying membership of the Organization to those who may discriminate on the grounds of nationality or origin, acting in accordance with the fundamental principles of justice, equality and democracy;
7. Protection of the constitutional rights of Jews through cooperation with international institutions and the State of Israel;

8. Promoting the unification of the Jewish people and the Jewish community, recognizing the leading role of Israel;
9. Facilitating contacts with the State of Israel;
10. Contribution to the assertion of the rights of Jews to their identity and culture;
11. Protection of social, religious and civil rights of Jews in Azerbaijan and throughout the world;
12. Contribution to the development of the Jewish educational system by protecting and supporting Jewish traditional and cultural traditions.

Decision: accept all of the above constitutional amendments, and apply for membership in the WSO

Voted: unanimously.
